NONEXCLUSIVE CONTRACT BETWEEN TALENT AND TANGERINE TALENT LLC

- This agreement is made and entered into this _____ day of _____, 2014,between Tangerine Talent LLC (herein referred to as "Agency or Agent") and ______ (herein referred to a "Talent"). Subject to representation of Talent and other good and valuable consideration, the parties agree as follows:
- I the Talent hereby employ Tangerine Talent LLC as my nonexclusive talent agency for a period of one

 (1) year from date hereof to negotiate contracts for the rendition of my professional services as an artist, or
 otherwise, in the fields of print advertising and other fields of entertainment.
- 3. Talent desires to develop or continue an acting, entertainment, and/or modeling career and wishes to engage the Agent as representative, consultant, advisor and promoter. Agent is hereby appointed as the Talent's agent in this region to exercise reasonable efforts to seek and negotiate employment services in print advertising, promotional activities and similar fields in furtherance of the Talent's occupation and career. This is a non-exclusive agreement. Meaning talent may be represented by other agencies in the area. Write in any limitations to regions Agency is to represent Talent.
- 4. As compensation for Agent said services agreed to be rendered hereunder, I the Talent hereby agree to pay Agency a sum equal to twenty percent (20%); not to exceed maximum rate shown on fee schedule of all monies or things of value as and when received by me directly or indirectly, as compensation for my professional services rendered or agreed to be rendered during the term hereof under contracts, or any extensions, renewals, modifications, or substitutions thereof, entered into or negotiated during the term hereof and to pay the same to Agent thereafter for so long as Agent remain licensed. It is expressly understood that to be entitled to continue to receive the payment compensation on the aforementioned contracts, after the termination of this agreement, Agent shall remain obligated to serve me and perform obligations with respect to said employment contracts or to extensions or renewals of said contracts or to any employment requiring my services on which such compensation is based.
- 5. In the event that I the Talent do not obtain a bona-fide offer of employment from a responsible employer during a period of time in excess of four (4) consecutive months, during which said time I the Talent shall be ready, able, willing, and available to accept employment, either party hereto shall have the right to terminate this contract by notice in writing to that effect sent to the other by registered or certified mail.
- 6. Talent will keep Agency informed of all changes of address, email and phone numbers.
- 7. Talent agrees not to discuss rates on the set with or in front of other Talent.
- 8. Talent will inform agency of any availably two days before booking out i.e. Talent is going on Vacation or out of town talent will inform agency in writing two days prior to leaving.
- 9. Talent is responsible to pay Agency (20%) twenty percent of bookings within (30) thirty days of reviving payment if talent has agreed to accept payment directly. This (20%) does not include any additional agency fee offer by the casting director, producer, production company or advertising agency.
- 10. Agency is authorized to use Talent's name, likeness and qualifications to publicize Talent in connection with representation of Talent.
- 11. Controversies arising between us under the provisions of the California Labor Code relating to talent agencies and under the rules and regulations for the enforcement thereof shall be referred to the Labor Commissioner of the State of California as provided in Section 1700.44 of the California Labor Code.
- 12. Tangerine Talent is further authorized to contract for, bill, collect and receive sums payable and derived from my services, and upon receipt of the sums, to deposit them in Tangerine Talent's accounts, directly, and to deduct therefrom all sums owing to Tangerine Talent pursuant to this Agreement.

- 13. In the event that Agent shall collect from me a fee or expenses for obtaining employment for me, and shall fail to procure such employment, or shall fail to be paid for such employment, Agent shall, upon demand therefore, repay to me the fee and expenses so collected. Unless repayment thereof is made within forty-eight (48) hours after demand therefore, Agent shall pay to me an additional sum equal to the amount of the fee as provided in Section 1700.40 of the California Labor Code.
- 14. The parties agree and I the Talent acknowledge that I the Talent am an independent contractor. This contract and the relationship between the parties does not constitute employment. I the Talent am responsible for all taxes owed upon my earnings and am not eligible for unemployment from Tangerine Talent.
- 15. Tangerine Talent shall not be liable for any injuries or damages sustained by Talent or caused by others during the course of performing any work negotiated during the term of this Agreement.
- 16. Talent warrants that he/she has fully read and understands the terms within this

Agreement. And has entered into this agreement freely and with such knowledge And advice he/she deems necessary. He/She indicates they are of legal age to enter into such agreement. (If Talent is child, parent or legal guardian signature Is required.) No representations or warranties other than those expressly made Herein have been made by the Agency.

- 17. This instrument constitutes the entire agreement between us. Statements, promises, or inducements made by any party hereto that are not contained herein shall not be binding or valid, and this contract may not be enlarged, modified, or altered, except in writing signed by both the parties hereto; and provided further, any substantial changes in this contract must be approved by the Labor Commissioner.
- 18. Agent here by agree to deliver to me an executed copy of this contract.
